

SMS PRIVACY POLICY

This SMS Privacy Policy (this “Privacy Policy”) describes how we at Seiler, Singleton & Associates, PA (“Seiler, Singleton & Associates, PA”, “we”, or “us”) collect, use and disclose your personal information in connection with your use of the services to receive short message services and/or multi-media services for marketing and non-marketing purposes from us (“SMS Services”). This Privacy Policy is strictly limited to the SMS Services described herein and does not relate to the collection or use of personal information through any of our other services. In addition, it has no effect on and is unrelated to any other privacy policy(ies), if any, that may govern the relationship between you and us in other contexts. By enrolling in, using or accessing any of the SMS Services, you agree to the collection, use, and disclosure of your information as described in this Privacy Policy. If you do not agree to this Privacy Policy, please do not use or access any of the SMS Services. This Privacy Policy is incorporated into our Terms of Service covering SMS Services.

INFORMATION COLLECTED ABOUT YOU

Personal information we collect about you through your use of the SMS Services may include first name, last name, mobile number, address, email address, job title, and birthday.

We may use cookies or similar technologies on our website or websites associated with the SMS Services to automatically collect your interactions with any URL links included in the Messages.

USE OF PERSONAL INFORMATION FOR SMS SERVICES

We use your personal information to provide you with our products and services, to respond to your inquiries, to send you important updates, and to send you other relevant information. We may also use this information to market our products and services to you, including by the SMS Services subject to your consent.

DISCLOSURE OF PERSONAL INFORMATION

We do not share or sell your Personally Identifiable Information to third parties for marketing or promotional purposes. **No mobile information obtained as part of SMS consent will be shared with third parties or affiliates for marketing or promotional purposes.** However, we may share your information in the following circumstances:

Business Operations. We may share your information with third-party service providers who assist us in performing essential business functions, such as payment processing, customer support, and website maintenance. We may also share text message opt-in consents or related mobile telephone numbers with our service providers and vendors that we use to provide our SMS Services.

Compliance with Legal Requirements. We may disclose your personal information if necessary to comply with any applicable law or regulation, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights or property.

Sale or Merger. In the event of a sale, merger, or acquisition of our business, we may transfer your information to the acquiring company, but your data will continue to be protected in accordance with this policy.

OPTING OUT

If you wish to stop receiving text messages from us, reply STOP, QUIT, CANCEL, or UNSUBSCRIBE to any text message sent from us.

ELIGIBILITY

To receive SMS Services, you must be a resident of the United States and 18 years of age or older.

CHANGES TO THIS PRIVACY POLICY

We may update this Privacy Policy at any time, including to reflect changes to our practices or for other operational, legal, or regulatory reasons. We will post the updated Privacy Policy on our website, and the “Last Updated” date at the top of this document will be revised accordingly. Please review it frequently. By continuing to use the SMS Services after any such changes have been made, you accept and agree to the updates to the Privacy Policy.
